

United Associations of Heather Ridge: Public safety meeting

On July 5, the UAHR committee hosted a well-attended public safety meeting at the Heather Ridge County Club. Speakers included Ward IV Councilwoman Molly Markert and Aurora Police Area Representatives (PAR), Captain Jim Puscian and Sergeant Damon Vaz. Heather Ridge is in Police District No. 1. The officers outlined police operations, procedures, and policies. Concerned residents asked many questions. The underlying question was how safe are we?

Councilwoman Market emphasized her strong belief in and support of Neighborhood Watch programs. She emphasized that citizens have to participate in their own safety and be pro-active.

Officers Puscian and Vaz compared crime statistics through 2011, clearly showing a downward trend for District No. 1. In fact, 2011 could be the district's safest year in a decade.

Officers Puscian and Vaz further explained

Real Estate in Heather Ridge

The big news is shrinking home inventory. As Metro Denver's average single-family prices rise slightly, and condo prices nudge down, fewer homes are for sale. What's happening?

Presently, there are approximately 19,500 homes and condos for sale in metro Denver, down 20 percent from this time last year. Over two years ago, inventory exceeded 30,000 as foreclosures flooded the market. Today, lenders and government programs are holding inventory back from the market to stabilize home prices. Secondarily, but not by much, the avalanche of paperwork is drowning the foreclosure system.

For sale inventory in Heather Ridge is down, too. As of Aug. 8, there were only 15 units for sale. A year ago, that number approached 40. Three years ago, it was higher.

Shrinking inventory doesn't mean real estate problems are going away. Similar to unemployment figures, unsuccessful sellers are withdrawing their homes from the market, thus skewing statistics by not participating. Out of frustration, many are giving up

and awaiting the sheriff's knock at their doors. In a growing number of cases, before foreclosure happens, owners continue to occupy their homes for years without making loan payments, paying property taxes, or keeping it insured. Called "the phantom inventory," once foreclosed, there is now talk at the federal level to rent foreclosed homes to low income and homeless people versus going to market.

If you own a Heather Ridge property and are thinking of selling it, Pete and Van have their fingers, hands and souls around today's real estate market. the importance of Neighborhood Watch programs and how they help the police apprehend perpetrators. This program is the eyes and ears of the police. Without it, neighborhoods are less safe.

The police officers emphasized the following points when reporting a crime:

- If a crime has been committed without any suspects, please report it via Internet whenever possible. You can go to www.auroragov. org then and click on Departments, then police reports.
- Online Crime Reporting: This system allows you to file a non-emergency police report in cases where there is no suspect information and no immediate danger to persons or property, such as a vehicle break-in that happened overnight. The following options are available for online crime reporting:
 - Lost or Missing Property
 - Damaged Property with no known suspects

- Theft, under the felony threshold, with no known suspects (excluding firearms, explosives or motor vehicles)
- · Vandalism to a Vehicle
- Larceny from a Vehicle
- Supplemental Report of Stolen Property from a Burglary

For a crime in progress, call 911 and stay on the line so the responding officers can ask you questions via the 911 operator. This is important because you now become the eyes and ears of the police.

At the conclusion of the meeting, volunteers were asked to help form Neighborhood Watch programs in Heather Ridge. There was strong support with many wanting to participate. The PAR officers emphasized that Neighborhood Watch programs should be separate from their HOAs. Neighborhood Watch programs work under the Aurora Police Department, not HOAs and their policies.

Neighborhood Watch was the dominant theme at the July meeting. Veda White was guest speaker. She organized a Neighborhood Watch program in her community at Summit Park five years ago to address their rising crime issues. Her area was experiencing a rash of burglaries, an active pedophile, car break-ins, tampering with mailboxes and a small group of teenagers who were vandalizing property.

Currently, Veda has 80 percent participation from residents in her HOA. This year, Summit Park has experienced only the theft of one bicycle. This is truly a testimony to the effectiveness of a Neighborhood Watch Program.

Veda also stressed that once the program is in place, hardly any time, effort or meetings were involved in its upkeep.

Beverly Brown from Strawberry II is heading up the Neighborhood Watch for Heather Ridge. She will take over the "Safety, Crime and Security Report" in *Metro Matters*. Bev can be reached at *brownbe_nwatch@comcast.net*. Already, 13 residents have signed up to attend a Neighborhood Watch Orientation Class. With everyone's help, this overdue program should be successful!

The annual **Cocktail Party** for HOA boards was discussed. Many members were unable to attend due to summer travel or the early time frame. It was decided to move the date to September and change the time to 6–7:30 pm for next year's event.

HRCA meets each month, the second Tuesday, at 6 pm, in the 19th Hole at the Golf Club of Heather Ridge. Its goal is to promote the economic and social interests of the community through communications. So far, business has been brisk!

The flagship of this effort is *Metro Matters* magazine. Now in its second year, it is budgeted under the HRMD General Fund. Its mission

Important Message from Brownstone Services. In the past few months, there have been many crime issues in the Heather Ridge area. Despite these unfortunate events that appear to be random acts and because Strawberry is part of a large area of properties affected on each occasion, there are many things that you, as residents, can do to keep possible thieves out of your neighborhood and avoid break-ins to your property and vehicles.


 Auto Safety: After the last set of breakins, Brownstone inspected every vehicle on the property and found that several had cracked/ open windows and unlocked doors. Many vehicles had various electronics (cell phones, navigation units, mp3 players, etc.), detachable face stereos (still attached), CD cases/books, TVs, various bags (shopping, backpacks, duffel bags, etc.) and mail — all clearly visible. While these items are extremely enticing to thieves, the theft of your mail can be one of the most destructive to you. Identity theft, among many other fraudulent activities, is possible when criminals get hold of the information contained in your mail. Making sure that your car is locked, your windows rolled up, and any electronics/personal items or mail are out of sight or removed are essential steps in making your vehicle and this property less of a target for thieves.

If you are a victim of theft, PLEASE file a report with the police. Whether you believe that the culprits will be caught based on that report or not, this information is key for the police department when establishing areas affected by crime (along with any trends associated with) and in charging criminals with those crimes. If these warnings are not taken seriously, and the current trends continue, the vehicle theft/breakins will get much worse before they get better.

- Windows and Doors: Make sure you keep ALL first floor windows closed and locked at night. Yes, it's hot, but better a little toasty than waking up to an uninvited guest.
- **Lights On:** Consider keeping your porch and patio lights on at night. A burglar's best friend is the dark. Using a little electricity is way

cheaper than the cost of a break-in. Consider adding motion detectors to your outside lights.

• Be Aware: If you see anything at all that does not look right, call security and the Aurora Police Department.



Privacy or Safety. In our cozy settings, everyone loves their privacy. Aurora Police and Fire Departments ask that you be aware of the following:

- That big shrub that provides privacy for your patio and/or windows may also provide cover for unsavory folks who watch and wait for an opportunity. Your shrub should have a limited trim and be cleaned at the bottom to allow visibility.
- Walks must be clear to allow emergency personnel, equipment and gurneys.
- Drives must be clear for patrol cars, ambulances and fire trucks.
- Some addresses are hard to locate because the unit numbers are hidden by overgrown trees or bushes.

The board and Strawberry's landscapers know what the city has asked be done in the community. Privacy will be preserved as much as possible. However, a primary obligation is the safety of the community and to comply with Aurora Police and Fire Departments. When the landscapers trim overgrown trees and bushes, they are acting on a work order from the board. Please do not interfere with their work. They cannot and will not stop the trimming on a homeowner's demand.

Pools. Pools will be open through Labor Day. Take advantage of this while you can. Locks will be changed, so save your key to swap for a new key next year. New umbrellas at the family pool were broken. There will be new umbrellas and furniture next year. If you see anyone misusing pool furniture, notify security.

BEE-utiful. With summer comes some not-so-welcome insects like yellowjackets. Reusable yellowjacket traps that are non-toxic and will NOT trap beneficial honey bees are available through your HOA. Call CAP to get a trap set up in a problem area.

Keeping Cool. With 15 straight days (and counting) of 90 degree plus temperatures, everyone is looking for ways to beat the heat without the pain of a HUGE electric bill. There is, of course, the pool, but you can only stay in there so long without looking like a prune. Portable air conditioners are a great alternative.

Our Xeriscape is Complete!

Our xeriscape project was completed by JBK Landscapers in early July. It is a beautiful improvement over the previous water-hungry turf. Residents have responded positively and no complaints.

There is plenty of variety and plenty of green. The green should increase dramatically by next year as the plants grow and expand. There should also be more color when the plants produce flowers and turn color in the fall. As of now, water use has decreased only slightly. Next year, with better control of the clock monitors, the community will need to water only one or two times a week. Each watering will be longer to

Two zones that were updated with xeriscape roots to grow deeper.

The growth of the blue grama lawn is noteworthy. It was started



by seed, not sod. It grew fast and now presents a soft spring green carpet. It is lovely to look at, but it is not suitable for people walking all over it. In Chimney Hill, people rarely walk on the grass because the slopes are too steep and strips are too narrow. Keep your bluegrass turf for areas with lots of traffic (like the golf course). The blue grama needs to be weeded this first season and watered slightly. It is supposed to be allowed to grow to 6–8 inches, which means that it will need only one mowing a year — in mid October — and only one watering a week thereafter. Imagine that!

zones was covered with 4–8 inch cobble. This was because the narrow, steep, sunburned strip was just bare and ugly. Nothing grew there. The cobble stabilizes the slope. In the other areas, there is a mixture of attractive mulch, impressive boulders and lovely dry-adapted plants.

The biggest problem has been rabbits! They have totally overpopulated the community. There have been three crops of rabbit babies to date. They are eating the Echinacea and the northern sea oat grass plants in the xeriscape areas (as well as the flowers and veggies in residents' gardens). Aside from the rabbit-ruined plants, all other xeriscape plants are doing really well.

The plants used in largest numbers were two species of Mahonia. Mahonia repens, a creeping grape holly, likes sun, grows into a large shrub and looks great in all seasons. Mahonia aquifolium compacta, a compact Oregon grape holly, is a low growing shrub that is especially good in shady areas.

Other plants in the xeriscape garden include Lonicera korokowii, a blue velvet honeysuckle, which is a lovely shrub with pink flowers in spring and summer and red berries in late summer that are loved by birds like robins. (Barbara Stein describes this shrub in her story, "A Patio with a View," on page 23.) The plant loves sunny areas or partial shade.

A lovely grass is Chasmanthium latifolium, or northern sea oats. It grows 18–24 inches and at maturity, is topped by lovely green oats. (Unfortunately, it is also an occasional rabbit food.) Some of the best flowering species are Coreopsis, Salvia, (catmint), and a favorite low growing species, Artemesia (silver mound sage). An edge plant is Thymus (thyme), which spreads a beautiful mat of pink, purple, yellow or white flowers in late spring and early summer. These are 10 of the most common plants in the xeriscape zones. If, as you pass by, you like any particular plants, you can see what they are and buy some for your own garden. All are available at Nick's Garden Center.

Water Audit. ReSource of Boulder did a water audit on Monday, July 18, starting at 8 am. Board President Melissa Miller and Marc from Perfect Landscape were there. They walked most of the property with the two irrigation audi-

tors. They spent the whole day checking every clock and zone, then doing catch can tests on 10 zones to estimate the DU (distribution uniformity) — a measure of the efficiency of the irrigation system.

Previously, a DU for the xeriscape grant areas was 36 percent (average), based on 11 zones with 451 catch-cans. According to Scott Kolowitz of Aurora Water, anything below 50 percent is inefficient. This audit is free, but you have to call Misha Delaney, 303-999-3820 x217, to get a place in line. Call now for an appointment for next summer. They are busy.

choice.

Now, a few things about what's going on in Chimney Hill.

On July 19, the **HOA meeting** convened ontime. As always, there were a lot of important issues to discuss — some leaking chimneys and a sinkhole between two townhouses were a couple items on the agenda. The sinkhole will be filled. How to handle the leaks is being discussed.

New siding was installed on the north side of 2021 S. Worchester because the old siding there had rotted all the way through. The contractor used HardiPlank instead of Masonite. It is more durable, and should last longer.

The **annual Town Hall meeting** is on Nov. 15. Even though it seems far away, I would like to ask all residents to plan on attending. There are a few things that the community and HOA need to decide. At the last meeting, we decided to re-evaluate contracts with the landscape and management companies. To save money, and get timely service, we are looking to hire a handyman for the odd jobs around the property.

During the meeting, a suggestion was made to put together a committee to concentrate on these issues. We anticipate that it will take a few weeks to come up with the decision. The board is looking for one or two people in the

community who would like to participate.

Chimney Hill has 116 homes, but only six board members. This sparse representation of the community is not good. It is also difficult to make important and urgent decisions during the board meetings when several people are on vacation, ill, or attend school in the evening. Ideally, we would like to have at least one person from every cul-de-sac on the board. This way it will be easier to spread the good news and get help within the community when needed.

Even if you do not want to become a board member, I encourage you to attend a few meetings. You'll learn how the meetings are conducted, can make suggestions, and offer your expertise.

Our townhomes are 30+ years old. They require a lot of preventative maintenance in addition to some urgent repairs. HOA boards set and maintain budgets, and raise fees based on projected expenses. Therefore all residents must be conscientious about what is going on, to keep the HOA dues low.

The board tries to use the money for meaningful upgrades that will help beautify and improve Chimney Hill. Everyone should report to their HOA manager or members of the HOA board any infractions, including inappropriate water use, running sprinklers, and pool temperature being too hot or too cold. Water costs are high. Water can do a lot of damage to building foundations and personal belongings. Money spent to repair these damages could have been used for property improvement instead.

In May, Burgundy neighbors held a "painting" party that saved their community a \$1,000! I know that a lot of people in Chimney Hill already contribute. Some people plant beautiful flowers and bushes. I saw my neighbors spread mulch around protruding tree roots to make a common area look better. A little extra effort by a few will add up into savings for all!

On a personal note. Even though this is not the board's opinion, and it has not been discussed, I would like to see that in the future the HOA use the services of people who live in the community — electrician, plumber, painter, handyman, etc. Even if a payment for their services would be the same as now, I hope these people would treat us as their family, since they

have a vested interest here.

Here is an example of how one resident's experience helped in interpreting the results of the job for which we hired a professional company. Mark Carapella has over 30 years experience working for Denver and Aurora, specializing in waste management. He spent hours evaluating a sewer lines report, pointing out some short-comings in the report. We are in the process of presenting these findings to the company that did the job. Mark also spent some time creating a map of the Chimney Hill sewer system that we'll be able to use in the future.

Landscape policy: Residents are reminded that the landscape policy stated in the Declaration of Condominium is:

"Any resident wishing to make major changes in the landscape near their townhouse, for example, the removal of junipers, trees, turf, etc., must submit a request with a diagram and/or clear description of the changes the resident wishes to make, to the HOA Board for its written approval. The Board must reply within 30 days or the request is considered approved. Failure to get approval may result in the Board revising the new landscape at the owner's expense."

This is in accordance with the Declaration of Condominium. Changes already made are "grandfathered" in. Minor changes to aprons, sidestrips, small areas adjacent to the steps and patio do not need approval.

As much as possible, and for all major changes, xeric plants (species adapted to Colorado's dry climate) should be used to save on water costs. Nick's has an entire section of xeric plants and very knowledgeable personnel.

 Please Recycle! Alpine may be putting smaller 95 gallon recycle containers (see photo) in the trash enclosures to make it easier for everyone to recycle. Thanks to all those residents who are filling the big recycle dumpsters. Please Recycle!



Projects done; projects under study. So far in 2011, all the roofs have been replaced, along with many gutters and downspouts. In addition, construction of new concrete drain pans along interior roadway to improve drainage during the summer or winter were completed.

Two Studies are Currently Ongoing. In September, the capital reserve study on engineering will help determine future HOA fees and reserve needs. The board is quite eager for this report, because it will be used to formulate the 2012 budget, an annual event that is fast approaching.

Another study specifically addresses interior asphalt maintenance. Initial reports indicate that HRS asphalt is in reasonably good condition, but needs corrective measures to prevent further deterioration. One asphalt problem is its buildup in front of garages. This may cause water to backup into garages. A possible solution is to remove the old asphalt in front of garages and replace it with a concrete apron extending outward. More information to follow.

Security issues, violation notices, parking. Board Director John Hartnett oversees these issues and others (architectural control). Working with Covenant Security Services, John has had a busy summer trying to make HRS a safer and better community.

Aurora police report less crime in the Heather Ridge area than in previous years, yet there have been incidents. In HRS this summer, John posted three warning notices about break-ins, suspicious people knocking on doors and one

At the board's direction, Westwind is mailing out Violation Notices about open garage doors, debris left in front of units and on interior streets, and repairs needed for fences and garage doors. If you received a violation notice, please accept the board's good intentions to protect the community.

Parking congestion is still a problem. Owners and tenants are strongly encouraged to park in their garages. Garages are for cars, not storage. In particular, large vehicles parked outside of their garages must not overlap onto neighboring driveways. Residents are encouraged to report such issues to Westwind as well as problems or violations. At the board's direc-

Chimney Hill: Patio with a View

I love to sit on my patio in summer. Sometimes I am listening to the sounds of birds in the environment: Canadian Geese, Mourning Doves, Mallards, House Sparrows, Crows, Black-Capped Chickadees, Goldfinches, House Finches and the American Robin are some of the birds I hear flying by or stopping.

Watching their behavior is entertaining. Take one example — the sometimes takenfor-granted robin. This bird, a member of the thrush family, runs along the grass and often stops at my bird bath for a drink. After drinking, it jumps into the bath and splashes with abandon while other robins wait their turn. The robin is a noisy bather. The splashing water sounds are delicious.

Now that the red/orange berries on the honeysuckle bushes next to my patio have ripened, robins run up to the bushes, stand a bit, seeming to gauge the distance or angle of the berries on the bushes above them, planning their approach. When they are ready, they jump onto the deli-

cate branches. While in the branches, they eat as many berries as they can. My husband Marc says that this would be comparable to a man jumping three stories high onto a high wire and then grabbing a tiny piece of fruit in his mouth. The robin is quite the athlete.

Yesterday, three robins were jumping on the honey-suckle bushes, chirping excitedly. One may have been in training because, at some point, they all relaxed on the bird bath ledge while one fed berries to a younger one. Its breast feathers were mottled rather than red/orange.

I pretended to be nonchalant, focusing only on grading my students' papers, trying to avoid any eye contact. (I don't see you.) They ignored me as if I were just inanimate patio furniture. They were more entertaining than my papers, which is why I do my grading outside during the summer.

Next time — squirrels. Why not see you what you notice and hear when you look and listen to your environment?
