### Yard sale past and future

The Yard Sale Committee held a debriefing meeting on Aug. 8 to discuss budget, signage, advertising, and announcements to the Heather Ridge community, and post sale pickup of items not sold. Representatives from Strawberry, Chimney Hill, Burgundy and Fwy 16 were present.

The committee decided to stay within a limited budget for the first community sale, concerned that it would not be held again next year. Ads were placed on Craig's List, *ClassifiedsGiant.com* and in *Metro Matters* (July and August issues); all were free of cost. Lettering for signage, markers and poster board for arrows were the only expense. Aug. 4 was chosen to increase traffic because Dam East, Dam West and Ptarmigan were having yard sales on the same day.

The committee got these suggestions:

- Signage: Purchase six large, waterproof signs for the entry corners on Iliff Avenue and Yale Avenue. Install them three days before sale. Reuse this year's signs and arrows for directional purposes.
- Advertising: Place free ads again. Pay for advertising in *Aurora Sentinel* at \$25 per week (online only) and Thrifty Nickel at \$5.50 for the first 10 words.
  - · Announcements to the HR community: The commit-

tee recommends a May yard sale date to be announced to the HR Communities in *Metro Matters* and HOA newsletters for three months prior to the date chosen. One week before the sale, post announcements on HOA mailboxes.

- Post sale pickup: Salvation Army or ARC should be contacted one month prior to sale to arrange for picking up items that owners did not sell and want to donate.
- It was also suggested that at least one representative from each participating HOA be a member of the Yard Sale Committee and a contact person for his/her HOA.

On Wednesday, July 18, Neighborhood Watch had its regular meeting. Every seat was filled at the Strawberry Clubhouse. It was rewarding, to say the least, because it demonstrated that the word got passed to residents by volunteers in the program.

Be sure to thank your community volunteer when you see one of them.

On the program was Chief Dan Oates and J.D. Wykstra, Senior Resource Officer. J.D. reported a couple of items that everyone should find interesting.

One is a free program designed for elderly residents or those with severe medical issues. It is a Lock Box that provides a house key for use by medical personnel. The following are program requirements to be eligible. You must:

- Live in a private home or apartment
- · Reside within the City of Aurora
- · Have permission from the owner if you rent the home


- Provide a spare house key
- Agree to return the Lock Box if you no longer wish to participate in the program
  - · Sign a waiver of liability

Another item addressed is a form called "Special Needs Registration," which alerts the Police Department to any Aurora resident who requires special help during an emergency. Call J.D. to get this form, if you need it. There is a great deal of information on this form — too much to go into detail in this column.

PAR Officer Mark Lowisz also spoke during the meeting and mentioned that the perpetrator of several crimes in the Burgundy and Cobblestone communities has been apprehended. He was the subject of a "Footprints in the

#### The Fall Real Estate Market

Expectations run high for a good finish to the 2012 metro Denver real estate season. The spring season started in February when homes priced under \$200,000 started selling like hot cakes. Then, homes up to \$350,000 started selling quickly throughout the metro area, especially in Parker and Highlands Ranch.

When July started, the first six months of the year had achieved sales records not seen for four or more years. Foreclosures are still happening, but their numbers are down; however, short sales continue to be a problem. If sales continue as expected, 2012 could end with a shortage of inventory.

July is traditionally a vacation month with slower sales, but activity this year dropped off more than expected — possibly as a respite from a whirlwind spring. August improved, but still is not as strong as predicted. As inventory declines, buyers are becoming frustrated with rising prices, a faster pace of sales, and little time to ponder offers. Buyers looking to "steal a house" are losing out to ready, willing and able buyers who know today's market..

Seller concessions are still active. Up to 70 percent of all Heather Ridge sales include concessions. A seller concession usually means crediting the buyer funds at closing to pay for closing costs. Instead of negotiating 2 or 3 percent off the asking price, buyers may pay full price but ask the seller to pay 2–3 percent of the new loan amount towards their closing costs. Although many sellers object to this process,

seller concessions have kept the real estate market alive for many years.

The Heather Ridge market remainsl strong, but feedback from buyers and their agents indicates that older homes not updated are losing out to newer homes and updated/remodeled homes. Selective updating or remodeling increases resale values, but not all improvements may pay for themselves. Please call Pete or Van for their professional recommendations — it could mean more proceeds in your pocket.

Interest rates continue at record low levels. Buyers are getting loans; however, more financial data along with community information is required for approval. Scrutinizing HOAs, lenders are requiring financial statements, the number of rentals versus the number of owner-occupied units, cash reserves and HOA monthly default rate.

### **Homeowners' Association News**

### Heather Ridge South by Van Lewis

Summer is coming to an end. Start planning for winter. Please disconnect all exterior hoses, store your patio furniture and flower pots, and shine up a snow shovel. The new concrete driveways need special ice melt. Because non-approved chemicals could damage the surface, please use HOA provided/approved ice melt only. Watch for more information about ice melts.

Inspect your unit's exterior! Owners should be watchful for damaged siding — especially under eaves or overhangs; gutters and downspouts — bent, plugged, or improper drainage that sends water towards foundations. Please inspect exterior lamps for damage, install energy efficient bulbs, and remove all extension cords. (Remember, the HOA maintains the front garage lamps.)

Report trees and bushes too close to buildings. Put your garden beds to rest, removing dead annual plants and trimming down perennials. Inspect window wells for proper covers and proper height above ground level. Check for loose cinderblocks or retaining wall stones. Please call Janelle, Westwind, with any concerns.

**Mudjacking more front patios.** Two years ago, HRS mud-jacked about 20 front porches to level them and prevent porch cover damage. This fall, more porches

will be selected for leveling. If you think your porch needs help, please call Janelle. Mudjacking is for front porches only, at HOA expense. Other concrete surfaces such as front walk-



ways and back patios are the responsibility of owners. If leveling is needed for a sidewalk or porch, call Janelle for an inspection, a determination about who is responsible and a cost estimate.

Being good neighbors in HRS. Whether you are an owner or a tenant, please think of others concerning your pets, BBQ smoke, parked cars, noises, children's toys and other activities in the common areas. Animal complaints top the list: mostly about dogs barking, running loose, or pooping. (Residents complain about cats, too.) Removing dog feces is a constant problem made worse by pet owners who hose it off their patios into the common area. Please report all concerns to Janelle at Westwind. Owners in HRS live in close proximity to each other — sothink about how your actions might affect others before you do something.

Water and Other Issues. In an effort to conserve water Chimney Hill is installing dual flush toilet kits for standard toilets. Using a standard toilet, one family can use 70 gallons of water a day with 20 flushes. They will use only 42 gallons a day using a dual flush toilet kit.


CH is also checking for water leaks in your home when installing the new toilet. So far, 37 dual flush toilet kits have been installed. The goal is to install 100 kits this year.

A reminder — washing your car in your garage or outside on Chimney Hill property is not allowed. Residents who do not comply will be penalized.

Remember to report water leaks and sewer back-ups in a timely manner. If your basement is flooded, losses may not be covered by the HOA.

The landscape maintenance company finished itsannual trimming at the end of July. Some residents were upset because their bushes were cut too short. Other people were displeased that their bushes were not cut enough. The board will work with the landscaping com-

pany to try to do better next year.

**New Neighbors**. Phillip and Nora Martinez have purchased 2598A and moved in with their two sons. Karen Monson delivered a directory and floral arrangement to welcome them to our neighborhood

**Dumpster.** The clubhouse dumpster has been removed. It cost over \$1,000 per year for once a week pick up and had become an unattractive nuisance. That means it was being used by Doubletree residents, passing construction vehicles and numerous dog walkers. The doors have been removed also. If you have a party at the clubhouse, just bag up your trash and either take it home for Thursday pickup or leave it on the lower level of the clubhouse. Call one of the board members or the Oswalds to put it out the following Thursday.

Gas Leak. This leak by the clubhouse front door was noticed by Jean Ronald in early July when she came to inspect our property. Xcel Energy responded within a couple hours and fixed the small leak. It also inspected the hot water heater, gas fireplace (the pilot light is off) and pool heater. It was recommended that the trash and artificial Christmas trees be removed from the furnace room as they were a fire hazard. That was done the following day.

### New families in the neighborhood

For the first time in a few years, Heather Ridge was lucky to have two families of goslings on the Golf Course. Many of the residents enjoyed watching these little ones grow.

They hatched the day before Mother's Day, and now, two and a half months later, the goslings are already as big as their parents. They are still learning to fly, especially those tricky landings. They can now fly a few feet above ground, and for the most part, they are landing in

the water — a much softer landing for a novice flyers.

I always took it for granted that flying was instinctual and never realized all the training and teaching the parents do to help their young learn to fly. I live on hole #4. For the first time in about 10 years of observing Canada geese, I have finally been able to watch this process. It's been wonderful.

I have to say that the more I observe the golfers on the course, the more I wonder about some of them. I'm talking about the golfers that try to run over the geese. Just last night I

watched two golf carts, driven by men, purposely try to hurt a group of geese that were off to the side of the fair-

way. They didn't just try once. They circled around three times before I finally yelled at them to stop. I've seen this before, but not quite to this extent.

I realize that many golfers simply hate the geese. But until a dome can be placed over the golf course, golfers need to be educated to the fact that the course is a perfect wildlife habitat. An open space like the golf course invites geese and other wildlife. Here they find food, water and shelter. This is the great outdoors. If you don't

want the geese, drain the ponds and get rid of the grass.

If you don't want squirrels, take out the trees. It's that simple. Then what is left? No golf courses, all because golfers can't seem to share this environment that doesn't even belong to them.

Maybe golfers need to think of the geese as another built-in hazard on the course, kind of like a sand trap — another challenge to their game.

On the other hand, golf course management has a responsibility to tell the golfers that harming the geese will not be tolerated. There are state and federal laws in place that protect them.



I don't think it was appropriate and could have been handled differently with more grace and diplomacy, especially by someone who is known by all to be the right kind of guy. Scofflaws would not be caught in daylight doing something they considered wrong, I am not a scofflaw and what I was doing was not harmful in any way to any-

one or any entity.

Violence can be prevented and it can begin here

As our heart breaks from the sad and tragic events of the July 20 Theater Shooting in Aurora, we have an opportunity to turn some of our sadness and grief into action aimed at doing whatever it takes to prevent these tragedies from occurring in the future. A Key Violence-prevention strategy is good surveillance and intelligence. There are warnings prior to most of these events. Columbine shooters left a pre-developed website, reports of bomb making threats. A number of different people were aware the shooters had significant problems and were involved in questionable activities. However, no one in a position of authority was aware of all the signs prior to the event.

There is a system that has been established in Colorado so that community members among others could report in a safe and anonymous way their safety concerns. Tips are reported anonymously to a toll free number, 1-877-542-7233, or through a web reporting feature that can be accessed at www.Safe2Tell.org and



As part of the 2011 FasTracks Financial Plan, the I-225 project received \$90 million in funds to complete the section of the project from Nine Mile Station to Iliff Station.

SEMA Construction, Inc. is building the light rail guide way for the segment of rail between Nine Mile and Iliff, along with Colorado Department of Transportation's widening of I-225 from Mississippi Avenue to Parker Road. As part of that construction, the Yale Bridge over I-225 was closed in May with reconstruction to end in December 2012.
