# **HRCA News**

### Four Important HOA Bills Signed into Law

Governor Hickenlooper signed four bills in the HOA Reform Package on May 28, 2013. The bills are aimed at providing consumer protection for owners and residents in HOAs. House Bill 1276 (HB 1276) addresses HOA debt collection, and HB 1277 concerns licensing of managers and management companies. Here is a brief outline of each bill:

HB 1276: Goes into effect January 1, 2014, defining HOA collection policy, foreclosure, and payment plans. It outlines a step-by-step due process of enforcement for greater transparency between HOAs and its owners. Debt collection must be a defined process by HOAs beginning with giving notice to seeking judgments and recording liens. Concerning foreclosures, the HOA board must vote "on the record" versus directing a management company to initiate foreclosure. A foreclosure can begin only after a total of six-months worth of HOA fees is compiled. Lastly, delinquent parties owing funds to the HOA must have a one-time option for a repayment plan versus demand in full. (Only for the section of the statute that discusses the repayment plan does the term "assessments" include fees, charges, late charges, attorney fees, fines and interest on common expense assessments.)

**HB 1277:** Goes into effect January 1, 2015, with a compliance date of July 1, 2015. It defines and enforces licensure of community association managers and management company executives. The Colorado Division of Real Estate will have rule-making authority and enforcement powers.

HB 1134 was originally introduced to expand the powers of the HOA Information Office and the HOA Information and Resources Center both housed with Colorado Division of Real Estate. This bill proposed to further regulate controlling documents and procedures of HOAs and their property owners. It looks to include complaints, mediation, dispute resolutions, hearings specific to complaints, HOA elections, regulatory oversight over declarant-controlled boards for compliance, and protection for boards, director, homeowners, and residents from threats or defamatory conduct arising from HOA matters. In addition to requiring all HOAs (including pre-Colorado Common Interest Ownership Act communities) to register and simplify the registration requirements, the bill requires the Division of Real Estate to conduct a study that will assess options, costs and the need for the Division to have expanded authority. The study must be completed by December 31, 2013, and will result in legislation next year. The bill will go into effect August 7, 2013.

**Senate Bill 183** (SB 183) was signed by Governor Hickenlooper on May 10, 2013, and was effective immediately. It proposes to address drought and water issues concerning HOA landscaping requirements. Emphasis is on saving water by limiting water-guzzling turf, and defining turf by design and types of grass. HOAs cannot require installing any turf grass in a homeowner's landscape request, resolving HOA covenants that conflict with city or other watering authorities, and permitting HOAs to adopt xeriscape type designs and enforce design or aesthetic guidelines. HOAs may not levy fines against owners for failure to adequately water when water restrictions are in place and watering is in compliance with those restrictions.

# Back to the Future – 2007!

It's been five long years, but the general consensus is metro Denver is back to 2007 average home values. Recent sales in Heather Ridge have equaled top prices from then, after dropping 25 percent on average. The recovery has been long and painful, but Heather Ridge is back and ready for the next price run-up.

"Metro Denver had the highest share of homes selling within seven days or fewer in April among the U.S.'s major metro areas," according to realty data company ZipRealty. "Nearly 40 percent of homes listed in April sold within seven days," a rate that was twice the national average for April.

been pushing prices up beyond normal appraisal standards. So far for 2013, home appreciation is tracking at 10-11 percent, a rate too strong and unhealthy for a "normal" market growth. Homes in Heather Ridge are selling faster than metro rates, and it's not unusual for "clean, updated, and correctly priced homes" to sell within days, not weeks.

Outdated homes are selling too, but at prices reflecting needed work. Today's buyer in Heather Ridge wants a "move-in finished" home not needing repairs or remodeling. Simply stated, most buyers don't have the cash or skills to do that. If your home needs help, Pete and Van can give you the marketing edge and insights for an optimum sale. They are showing and seeing almost every home for sale in Heather Ridge, giving them an insight and knowledge that other agents might not have.

### Comparing Heather Ridge Neighborhoods

Except for Country Club Ridge, all Heather Ridge neighborhoods were built by EDI, Inc. from 1973 to 1981. They used

similar designs with different features to vary their products throughout Heather Ridge, a fact not readily known. For example, Cobblestone Crossing, Cobblestone, and Burgundy are almost identical neighborhoods. In Chimney Hill, EDI used the same model, but put a basement and garage under the units for more value. Sausalito neighborhood is a mix of Chimney Hill models with detached units and 2-car attached garages (no basements). Heather Ridge South and Fairway 16 are twins with identical models. Double Tree's homes are similar, but larger than HRS or Fairway 16's units. Lastly, Strawberry I units are stacked two-level buildings, whereas Strawberry II's units are smaller versions of Burgundy and other similar neighborhoods.

Please call your neighborhood experts Pete and Van to evaluate your home. Their creed is "Nobody cares how much you know until they know how much you care." So remember, please don't leave home without them!







### Water Restrictions and Outdoor Pools From a Ward IV constituent to me:

I fully understand the drought situation. I have my sprinklers set 2 times a week and have also greatly reduced the times it will run, beginning at 3 am each day. HOWEVER, I almost wonder if Aurora Water fully gets the message to conserve related to all the swimming pool openings. I have no problem with Utah or other covered pools. I do not see the need of running all the "open" pools full bore. Certainly that is NOT conservation!

From Aurora Water Manager to constituent and me: Thank you for the inquiry. First, we have some great information on our website to help you set your irrigation clock and maintain a healthy lawn this summer. Check out our watering information at <a href="http://tinyurl.com/WateringInformation">http://tinyurl.com/WateringInformation</a>

As for pools, you are absolutely correct that pool evaporation in Colorado is very large. Our Water Management Plan, which sets the implementation measures for each drought stage, includes a Best Management section for pools. We do highly recommend that all pools be covered when not in use, since up to 95% of water loss from evaporation can be saved through the use of a pool cover. We work with HOAs and the city's Parks, Recreation and Open Space department on many conservation efforts. Pools are included in this discussion. 

**2.5 million:** In July 1776, the estimated number of people living in the newly independent nation.

**316.2 million:** The nation's estimated population on this July Fourth.

### **Flags**

**\$302.7** million: Dollar value of shipments of fabricated flags, banners and similar emblems by the nation's manufacturers in 2007, according to the latest published economic census statistics.

### **Patriotic-Sounding Place Names**

Fifty-nine places contain the word "**liberty**" in the name. Pennsylvania, with 11, has more of these places than any other state. Of the 59 places nationwide containing "liberty" in the name, four are counties: Liberty County, Ga. (65,471), Liberty County, Fla. (8,276), Liberty County, Mont. (2,392) and Liberty County, Texas (76,571).

One place has "patriot" in its name. Patriot, Ind., has an estimated population of 209.

The most common patriotic-sounding word used within place names is "union" with 136. Pennsylvania,

with 33, has more of these places than any other state.

Other words most commonly used in place names are Washington (127), Franklin (118), Jackson (96) and Lincoln (95).

### **Fourth of July Cookouts**

The Hawkeye State was home to 20.3 million hogs and pigs. North Carolina (8.9 million) and Minnesota (7.8 million) were also homes to large numbers of pigs.

**6.3 billion pounds:** Total estimated production of cattle and calves in Texas in 2012. Chances are good that the beef hot dogs, steaks and burgers on your backyard grill came from the Lone Star State, which accounted for nearly one-sixth of the nation's total production. And if the beef did not come from Texas, it very well may have come from Nebraska (estimated at 5.1 billion pounds) or Kansas (estimated at 3.8 billion pounds).
