Call to Order/Quorum

Director Rowland noted a quorum was present and each Director present confirmed they were qualified to serve. Director Rowland referenced the District's mission statement.

Mr. Allen advised the Board that, pursuant to Colorado law, certain disclosures might be required prior to taking official action at the meeting. Mr. Allen inquired whether members of the Board had any disclosures of potential or existing conflicts of interest with regard to any matters scheduled for discussion at the meeting. Director Rowland reminded the Board that he is performing District website maintenance and office supplies provision services for which compensation is paid. Director Cronin noted he is involved with Golf operations. All Board members confirmed there are no other conflicts of interest.

Clubhouse Lower Level HVAC Replacement; Water Boiler Replacement; Contractor Awards The Board discussed the three bids received for HVAC airconditioning replacement. Mr. McConnell reported on the inefficient and aging water boiler noting it will likely need to be replaced in the near future.

City of Aurora Storm Sewer System Easement Agreement; Golf Course Impacts and Compensation Director Lewis provided a summary to the Board regarding negotiations with the City for silt removal from the golf course ponds caused by City storm sewer work. Following discussion, upon motion duly made and seconded, the Board approved an easement agreement for the City's storm sewer project suject to the City paying for the costs related to increased silt deposited into the ponds and silt removal from therefrom.

The Board of Directors of Heather Ridge Metropolitan District No. 1 (the "**Board**"), City of Aurora, Arapahoe County, Colorado (the "**District**"), held a regular meeting, via teleconference on October 17, 2024, at the hour of 4:00 p.m.

Prior to the meeting, each of the directors was notified of the date, time, and place of the budget meeting and the purpose for which it was called, and a notice of the meeting was posted or published in accordance with § 29-1-106, C.R.S.

NOTICE AS TO PROPOSED 2025 BUDGET

WHEREAS, the Board has appointed its accountant to prepare and submit a proposed budget to the Board in accordance with Colorado law; and

WHEREAS, the proposed budget has been submitted to the Board for its review and consideration; and

WHEREAS, upon due and proper notice, provided in accordance with Colorado law, said proposed budget was available for inspection by the public at a designated place, a public hearing was held and interested electors of the District were provided a public comment period and given the opportunity to file any objections to the proposed budget prior to the final adoption of the budget by the Board.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD AS FOLLOWS:

Section 1. <u>Adoption of Budget</u>. The budget attached hereto and incorporated herein is approved and adopted as the budget of the District for fiscal year 2025. In the event of recertification of values by the County Assessor's Office after the date of adoption hereof, staff is hereby directed to modify and/or adjust the budget and certification to reflect the recertification without the need for additional Board authorization. Any such modification to the budget or certification as contemplated by this Section 1 shall be deemed ratified by the Board.

Section 2. <u>Levy of Property Taxes</u>. The Board does hereby certify the levy of property taxes for collection in 2025 as more specifically set out in the budget attached hereto.

Section 3. Mill Levy Adjustment. When developing the attached budget, consideration was given to any changes in the method of calculating assessed valuation, including any changes to the assessment ratios, or any constitutionally mandated tax credit, cut, or abatement, as authorized in the District's service plan. The Board hereby determines in good faith (such determination to be binding and final), that to the extent possible, the adjustments to the mill levies made to account for changes in Colorado law described in the prior sentence, and the actual tax revenues generated by the mill levies, are neither diminished nor enhanced as a result of those changes.

Section 4. <u>Certification to County Commissioners</u>. The Board directs its legal counsel, manager, accountant, or other designee to certify to the Board of County Commissioners of Arapahoe County, Colorado the mill levies for the District as set forth herein. Such certification shall be in compliance with the requirements of Colorado law.

Section 5. <u>Appropriations</u>. The amounts set forth as expenditures in the budget attached hereto are hereby appropriated from the revenue of each fund for the purposes stated.

Section 6. Filing of Budget and Budget Message. The Board hereby directs its legal counsel, manager, or other designee to file a certified copy of the adopted budget resolution, the budget and budget message with the Division of Local Government by January 30 of the ensuing year.

Section 7. <u>Budget Certification</u>. The budget shall be certified by a member of the District, or a person appointed by the District, and made a part of the public records of the District.

ADOPTING A DIGITAL ACCESSIBILITY POLICY AND DESIGNATING A COMPLIANCE OFFICER

WHEREAS, the Heather Ridge Metropolitan District No. 1 (the "**District**") is a quasimunicipal corporation and political subdivision of the State of Colorado; and

WHEREAS, pursuant to § 32-1-1001(1)(h), C.R.S., the Board of Directors of the District (the "**Board**") is empowered with the management, control, and supervision of all the business and affairs of the District; and

WHEREAS, pursuant to § 24-85-103(2.5), C.R.S., the Chief Information Officer in the Office of Information Technology has adopted accessibility standards as specified in 8 CCR 1501-11 Rules Establishing Technology Accessibility Standards (the "**Rules**"); and

WHEREAS, pursuant to § 24-85-103(3), C.R.S., on or before July 1, 2025, the District is required to take action to comply with the Rules; and

WHEREAS, the Board desires to adopt this Resolution to implement a digital accessibility policy and designate a compliance officer.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE DISTRICT AS FOLLOWS:

- 1. <u>Adoption of Digital Accessibility Policy</u>. The District hereby adopts the Digital Accessibility Policy (the "**Digital Accessibility Policy**") set forth in **Exhibit A**, attached hereto and incorporated herein.
- 2. <u>Appointment of Compliance Officer.</u> The District hereby designates Rose Vallesio as the District's Compliance Officer (the "Compliance Officer").
- 3. <u>Severability</u>. If any part, section, subsection, sentence, clause, or phrase of this Resolution is for any reason held to be invalid, such invalidity shall not affect the validity of the remaining provisions.
- 4. <u>Effective Date</u>. This Resolution shall become effective as of October 17, 2024, and shall be enforced immediately thereafter and shall supersede any previous policy related to website accessibility.
- 5. <u>Ratification of Past Action</u>. The Board hereby ratifies any actions taken in the furtherance of the District's business related to website accessibility by legal counsel from January 1, 2023, through the date of this resolution.

EXHIBIT A

DIGITAL ACCESSIBILITY POLICY

1. **GENERAL**

- <u>a.</u> <u>Purpose</u>. The District is fully committed to providing accessible digital information to all members of the public. As part of this commitment, the District has adopted this Digital Accessibility Policy (the "**Policy**") to ensure the District's online services and digital communications comply with the Rules.
- <u>b.</u> <u>Scope.</u> The District is committed to providing persons with disabilities equal access to digital information, including information made available through the District's website and other digital content. This Policy has been developed to promote equal access to such digital information to persons with disabilities. This Policy applies to digital content produced by or under the control of the District, including the District's official website. Accessibility requests may be submitted to the District in accordance with this Policy.
- <u>c.</u> <u>Third Party Content.</u> The provisions of this Policy do not apply to third-party websites linked through the District's website, such as state or federal agencies, or digital content not under control of the District. While the District is not responsible for ensuring the accessibility of third party-controlled content, the District is dedicated to assisting individuals experiencing accessibility issues when possible.

2. COMPLIANCE INFORMATION

- a. <u>Compliance Officer</u>. The Compliance Officer will be the point of contact for accessibility-related accommodations for digital content. The Compliance Officer or its designee is responsible for responding to reports of inaccessible digital content and accessibility requests.
- b. <u>Testing Tools and Techniques</u>. The District utilizes a variety of tools, techniques, methods, and procedures to identify accessibility barriers and meet existing and new assistive technology needs. The District has engaged Streamline (the "Accessibility Vendor") to complete testing and remediation, ensuring the website and digital content contained therein are accessible and inclusive for users with disabilities in accordance with the Rules.
- c. <u>Accessibility Reports</u>. The Accessibility Vendor will review the District's website, user interfaces, and other digital content and summarize the same in a report provided to the District no less than annually (the "Accessibility Report"). The Accessibility Report will identify digital content that does not comply with the Rules. The Accessibility Vendor or the District, as appropriate, will take such steps as necessary to make such content compliant under the Rules. The District will maintain a record of the Accessibility Reports.
- d. <u>District-Controlled Content</u>. The District will ensure that digital content under the control of the District produced, developed, maintained, modified, or used by the District on or after July 1, 2024, is compliant with the Rules.

- e. <u>Digital Accessibility Plan</u>. The District will implement a digital accessibility plan (the "**Plan**") to provide a long-term strategic approach for digital accessibility. The Compliance Officer will coordinate and implement the Plan. The Plan will be updated annually to ensure ongoing compliance. The Plan will be in a form substantially similar to **Exhibit A-1** attached hereto.
- f. <u>Digital Accessibility Statement</u>. The District will post the following digital accessibility statement on its website prior to July 1, 2025:

Heather Ridge Metropolitan District No. 1 (the "**District**") is committed to providing equitable access to our services to all Coloradans.

Our ongoing accessibility effort works towards being in line with the Web Content Accessibility Guidelines (WCAG) version 2.1, level AA criteria. These guidelines not only help make technology accessible to users with sensory, cognitive and mobility disabilities, but ultimately to all users, regardless of ability.

RESOLUTION OF BOARD OF DIRECTORS CALLING ELECTION

HEATHER RIDGE METROPOLITAN DISTRICT NO. 1

§§ 32-1-804, 1-1-111(2), 1-13.5-511, 1-13.5-1101, and 32-1-1101(2), C.R.S.

At a meeting of the Board of Directors of the Heather Ridge Metropolitan District No. 1 (the "**Board**"), it was moved to adopt the following Resolution:

WHEREAS, the District was organized as a special district pursuant to §§ 32-1-101, et seq., C.R.S. (the "Special District Act"); and

WHEREAS, the District is located entirely within Arapahoe County, Colorado (the "County"); and

WHEREAS, pursuant to § 32-1-804, C.R.S., the Board governs the conduct of regular and special elections for the District; and

WHEREAS, the Board anticipates holding a regular election on May 6, 2024, for the purpose of electing directors and submitting ballot issues and/or questions to eligible electors of the District, and desires to take all actions necessary and proper for the conduct thereof (the "Election"); and

WHEREAS, the Election shall be conducted pursuant to the Special District Act, the Colorado Local Government Election Code and the Uniform Election Code of 1992, to the extent not in conflict with the Colorado Local Government Election Code, including any amendments thereto, and shall also comply with Article X, § 20 of the Colorado Constitution ("TABOR"), as necessary; and

WHEREAS, pursuant to § 1-1-111(2), C.R.S., the Board is authorized to designate an election official (the "**Designated Election Official**") to exercise authority of the Board in conducting the Election.

NOW, THEREFORE, BE IT RESOLVED by the Board as follows:

- 1. The Board hereby calls the Election for the purpose of electing directors and presenting certain ballot issues and/or questions to the electorate. The Election shall be conducted as an independent mail ballot election in accordance with §§ 1-13.5-1101, *et seq*.
- 2. That, in accordance with § 32-1-1101(2), C.R.S., the Board hereby determines that the interests of the Districts and the public interest or necessity in carrying out the District's objects and purposes call for the Elections and for there to be submitted to the District's eligible electors the proposition of issuing general obligation bonds or creating other general obligation indebtedness or any question or questions necessary to implement Article X, § 20 of the Colorado Constitution as applied to the Districts.

- 3. The Board names Ashley B. Frisbie as the Designated Election Official for the Election. The Designated Election Official shall act as the primary contact with the County and shall be primarily responsible for ensuring the proper conduct of the Election. The Board authorizes the Designated Election Official to take all action necessary or appropriate to effectuate the provisions of this resolution including, but not limited to, certifying and recertifying the ballot pursuant to § 1-13.5-511, C.R.S.
 - 4. Without limiting the foregoing, the following specific determinations also are made:
 - a. The Board hereby determines that: in addition to emailing to each registered elector at the email address provided by the county (or if no email is provided, by mailing to the household of each registered elector), notice of the call for nominations will be provided by 1) publication; or 2) newsletter, annual report or other mailing to the eligible electors of the District; or 3) posting on the District's website; or, if applicable, 4) for Districts with fewer than 1,000 electors, contained within a county of less than 30,000 people, posting at 3 public places and in the office of the clerk and recorder.
- 5. The District shall be responsible for the payment of any and all costs associated with the conduct of the Election.
- 6. The Board hereby ratifies any and all actions taken to date by general counsel and the Designated Election Official in connection with the Election.
- 7. This Resolution shall remain in full force and effect until repealed or superseded by subsequent official action of the Board.
