**II. Call to Order:** A quorum was established with 09 0f 10 HOA's represented. The meeting was called to order at 6:00 PM

## **III. Guests to address the Board:**

- A. Rob Lamphier and his assistant Terri Reid were invited to discuss some complaints from community members who had problems with service, or cold foods or the expensiveness of lunch time meals. They were already aware of most of the problems and have taken steps to resolve these issues.
  - ✓ They developed a "specials" menu for lunch which offers a choice of 6 different specials for \$6.00 which includes drink.
  - ✓ They are working with the GCatHR GM and his staff to resolve the wind tunnel effect between the kitchen and bar due to the HVAC system and also faulty kitchen doors
  - ✓ Will be sending out ValPak Money Mailers to boost sales at lunch and happy hour.

- ✓ Patrons do have trouble locating the establishment especially at night due to inadequate parking lot lighting which is also a safety and security issue. GCatHR has relocated the bus stop from the eastside of the entrance to the west side which has improved visibility during the day time.
- ✓ When the area greens up a little they will determine where to put signs for the establishment.
- B. Larry Ransford GCatHR Board Treasurer updated members on the progress being made on the irrigation system
  - The front 9 holes irrigation system should be completed soon. The contractor is averaging completion of two holes per week
  - The #5 pond will have the liner placed on Thursday May 5<sup>th</sup> When finished the pond will hold 85,000 gallons of water, and will be able to pump out 1200 gals of water per hour.
  - Mapped out on GPS system so everything can be controlled by the computer in real time.
  - All piping necessary for transferring water around the course has been laid.
  - Putting greens have been completed, and part of the driving range has also been finished

Larry also said that the GCatHR do not have finances to spend on any project except the irrigation system at this time. The GCatHR Board is working on long range plans for the completion of the irrigation system and also some long range plans for dredging of the other ponds.

B Bette Secord updated us on HRCA activities to include:

- building an off site owner data base.

- ➤ A Metro District sponsored cocktail party for each HOAs' Board Members.
